Trooper Saunders Remembered on 10th Anniversary

Those living in Tri-Cities recently got to see for themselves what it truly means to be a member of the WSP family.

Exactly ten years after Trooper Jimmy Saunders was murdered during a traffic stop, WSP employees from all over the state gathered on October 7, 2009, to keep Saunders' memory alive. They were joined by officers from nearby agencies and members of the general public who wanted to show their support for those who protect them.

In all, about 150 people filled the street at 28th and Lewis in Pasco, the site where Saunders was killed.

"Whoever coined the phrase 'time heals all wounds' didn't know Jim," said Deputy Chief David Karnitz told the crowd. "Time cannot and will not heal this wound."

The remembrance was held at 9 p.m., to mark the actual hour

of Saunders' death. Those gathered saw a 21-bell salute from WSP Honor Guard and seven of Saunders' academy classmates. A solemn flaglowering ceremony and a moment of silence capped the remembrance.

One of those not from WSP was Dan Morrisette, a state corrections officer at the Walla Walla prison. He wanted to pay respects to a trooper he'd first met when a prison bus loaded with dangerous inmates broke down beside the highway.

"I was pretty happy to see this big, tall trooper show up," Morrisette shared.

Prior to the public ceremony, a reception was held at the Hillcrest Memorial Center. Saunders' widow Billie, his children Megan and James Jr., and his sister Jennifer were the honored guests.

Hugs and smiles appeared to outnumber tears. Several retired troopers and spouses attended and the support for Billie was palpable.

No one had trouble figuring out which of the many children present was James Jr. He's the spitting image of his dad, especially when he smiles. At nine years old he entertained those gathered with a very polite personality and an exceptionally polished moon walk.

Jimmy's daughter Megan, 12, is now a head taller than her mother and growing well into young adulthood.

Along with the remembrances, Chief Karnitz had a message for today's

troopers about their own safety. He explained to the crowd that both regulation and tradition require a picture of the most recently deceased employee be hung in every WSP office.

"As much as it pains me to see that picture every day, I hope we never have to replace it with a picture of another employee," he said. "Please, be careful."

The memorial site at 28th and Lewis includes

a stone marker engraved with Saunders' image. His smiling face overlooks a place where traffic stops continue to occur on a daily basis.

"This is a natural place for violators from the freeway to pull over," District 3 commander Captain Shawn Berry said. "Over the years we have contacted literally thousands of drivers at this very spot."

One could easily argue that Jimmy, the consummate trooper himself, continues to watch over his brothers and sisters as they continue their dangerous work.

WSP Recovers from October Dust Storm

Interstate 90 between Moses Lake and Ritzville in Eastern Washington was closed more than 19 hours on October 4, 2009, because of blowing dust and poor visibility.

An impressive effort was given by District 4 and District 6 troopers, sergeants, Commercial Vehicle Division, Criminal Investigation Division, and Communications personnel. Sergeant Mike Rupert said Sunday afternoon that visibility in the worst of the dust storm was about 5 feet, and when it let up, visibility was still only about 20 feet. Fortunately no public safety personnel were injured.

It took days of cleaning equipment and assessing the damage to cars, electronics (computers and cameras) and other equipment from the dust storm.

60 Miles for a Breast Cancer Cure

My mama passed away from breast cancer December 10, 1998. My youngest brother passed away from lung cancer February 13, 2002. My cousin passed away from breast cancer June, 2002. I was diagnosed with breast cancer January 8, 2003.

After a lumpectomy, eight weeks of radiation, and five years of preventative medication, I am now considered "cancer free." I am now a six year survivor. The yearly mammogram isn't any less stressful. My passion for a cure isn't any less intense.

I had the honor and privilege this year to walk in the Breast Cancer 3-Day walk sponsored by Susan G. Komen on September 11 - 13, 2009. I walked with 2,200 amazing people over 60 miles for the fight against breast cancer. Within that 2,200 were 170 survivors and I am one of them. I am a SURVIVOR!! Together through donations, we raised over \$5 million.

The Breast Cancer 3-Day is an amazing journey that I will definitely participate in again. I got blisters and sore muscles. I had little sleep but met some incredible people. I was thankful to those that sacrificed for something that has touched my family, my friends and me. The sacrifices that we experienced during the 3-day walk were minimal in comparison to what some have sacrificed during their breast cancer journeys.

My cousin and I, along with the other 2,200 walkers, started the 60 miles at Shoreline Community College on Friday, September 11. It was dark and chilly, but the energy that was apparent in all of the

walkers was electrifying. After walking 21 miles, sweating, hurting and crying, we arrived at our campsite. Our first day was incredible. The next morning, after sleeping in our pink tent, my cousin and I got up (not as gingerly as the day before when we got out of our comfortable beds at home) and started the walk of a lifetime all over again. We left the campsite around 7:30 a.m. and walked a 21-mile loop around Everett. Needless to say, the blisters became one with my feet and the muscles were not so happy with me. But once again, after lots of water, port-a-potties, and strangers cheering us on, we made it back to camp. Warm evening showers were now something treasured and luxurious.

The last day of the walk was September 13. We were bused to North Seattle to start the last day of the most incredible journey I've ever encountered. We walked to Green Lake, to Lake Union, over the Fremont Bridge, to the Marina, up Capital Hill (we now affectionately call the demon hill) to Volunteer Park, down through the Broadway and Pike Street areas, to the waterfront and back up to Seattle Center. Key Arena was Sanctuary. This was where the walk came to an end. Or so we thought. Of course there was the very emotional Closing Ceremony, but this finish line was not the end. To me this walk was the beginning. It was the beginning of helping find a cure. The beginning of helping to give my daughters in law, my future grandchildren, my neighbors, my friends, my family and me a future without breast cancer.

Never, ever give up hope because everyone deserves a lifetime!!!!

WSP Tissue Donation Program

In September 2009, the Washington State Patrol referred 19 deaths to SightLife.

On September 6, 2009, in District 2, a one car vs. pedestrian collision occurred. A 26-year-old male lost his life in this collision. He was registered as a Washington State Donor, donating his corneas. His corneas were shipped overseas for transplant.

On September 14, 2009, in District 4, a car over embankment collision occurred. A 34-year-old male lost his life in this collision. He was registered as a Washington State Donor, donating his corneas. One recipient of his corneas was a 71-year-old male from Washington and the other cornea recipient was a 58-year-old male also from Washington.

DID YOU KNOW?

Sergeant Darren Mihelich has twice been a recipient of a tissue donor? His first tissue transplant surgery was in November 2003, when he tore his ACL in a skiing accident in 2002. Then again in October 2008, he tore the same ACL while working on his home. He had another ACL repair in January of 2009, this time using a donor Achilles tendon, due to the prior repair that made his tunnels too large for the standard ACL repair.

Sergeant Mihelich stated, "Both times a donor ligament or tendon was utilized and I am grateful for the tissue program and I myself am a donor."






An Award Winning Agency, the 2010 WSP Yearbook

U.S. Flag Flown in Iraq Now in Union Gap

Trooper Sergio Cervantes recently presented District 3 Captain Shawn Berry and Assistant District Commander Lieutenant Jim Keightley a U.S. flag flown from one of Staff Sergeant Cervantes' vehicles while on patrol in Iraq.

The flag will be displayed in the District 3 Headquarters – Union Gap.

Trooper Cervantes is a Staff Sergeant with the Washington State Army National Guard, 81st Heavy Brigade Combat Team. While deployed, his unit, A Troop, 1-303 Cavalry Regiment, was responsible for providing security escort for the movement of military personnel, supplies, and equipment throughout Iraq.

Trooper Cervantes returned to duty with the Grandview Detachment on August 31, 2009, after completing his second year-long tour of duty in Iraq with the Washington Army National Guard.

In 2009, WSP had 14 personel deployed throughout the Middle East, six of soldiers recently returned with the Washington State Army National Guard. The State Patrol has personnel serving in all branches of the military reserves and the Army and Air National Guard.

HAVE YOU HAD YOUR FLU SHOT?

Have you had a seasonal flu shot yet? According to the Centers for Disease Control and Prevention (CDC), the single best way to prevent getting and spreading seasonal flu is to get vaccinated each fall.

Many people can receive the seasonal flu shot as part of their health insurance benefits-check with your insurer to find out how you can get this important preventive shot. Many local drug stores are also offering flu shots for a fee of around \$25-check with your local drug store to find out if this is something they are doing.

Additionally, this Fall the vaccine for H1N1 (Swine Flu) will be available. According to the CDC, the H1N1 vaccine will become available in mid-October, and will be distributed first to the most at-risk groups, such as children and pregnant women. To find out about the H1N1 vaccine, please contact your health care provider.

Prevention is Key

For the seasonal flu and H1N1, staying healthy and taking measures to prevent contracting the virus is best:

- 1. Wash your hand frequently (for at least 20 seconds)
- 2. Cover your cough (cough into your elbow and not into your hands)
- 3. Stay home if you are sick to prevent spreading illness

If you are experiencing flu symptoms, call your health care provider for treatment advice.

WSP Memorial Foundation 2009 Fiscal Year Update

Since 1983, the Washington State Patrol Memorial Foundation (WSPMF) has provided \$1,281,058 in financial assistance to Washington State Patrol employees and their families.

This last fiscal year the WSPMF provided 10 new scholarships and 20 renewable scholarships, which totaled \$30,000 to families of the Washington State Patrol. This is the eighteenth year of the scholarship program! This year, two of our fallen officers' children (Adam Hawn and Christian Frink) received an Educational Grant for books, room, board, and tuition totaling \$15,308.

In addition to the scholarships, the WSPMF has provided over \$44,495 in assistance to WSP families in need this year. The WSPMF was involved in the following activities:

- The WSPMF Dinner held in Seattle on April 18, 2009, raised \$19,330 for the College Fund of our fallen officers' children. Family members of Troopers James Saunders, Steven Frink, Cliff Hansell, James Gain, Frank Noble, and Officer Joseph Modlin attended the Memorial Dinner as our guest. The WSPMF Core Value Award Recipients were Troopers Nicholas Jennings, Todd Bartolac, Maxwell Criss, and CVEOs Leslie Walker and Steven Stiles who attended the dinner as our guests.
- A Christmas donation was made to the family of each employee on active military duty.
- A donation was made in the memory of each law enforcement officer/firefighter killed in the line of duty in the state of Washington.
- The WSPMF sent Angela Benson, daughter of Trooper Cliff Hansell, and Luanne Mason, daughter of Officer Joseph Modlin, to the National Law Enforcement Memorial in Washington D.C. to remember their fathers. They honored all 26 Fallen Officers by reverently placing each officer's photograph at the location where their names are forever enshrined on the walls of the National Law Enforcement Memorial.
- Purchased the Trooper James Gain Memorial sign, which was dedicated on March 6, 2009, at the Gee Creek Rest Area on I-5 at mile post 13.
- Participated in the dip for tips at the Ben & Jerry Ice Cream Event on April 21, 2009, raising \$1,407.04 for the WSPMF.
- On September 17, 2009, the Combined Fund Drive kick-off proceeds of \$555 were donated to the WSPMF.

Currently the WSPMF has 1,044 contributing members (907 active and 137 retired employees). The Washington State Patrol recognizes and honors the officers who served with distinction and died in the line of duty during the month of October.





Trooper James Saunders died on October 7, 1999, at the age of 31 from gunshot wounds while conducting a traffic stop in Pasco. At the time of his death, Trooper Saunders had served 8-1/2 years with the Washington State Patrol as a trooper. Saunders is the 26th Washington State Patrol officer to die in the line of duty.

Trooper Saunders began his State Patrol career on January 7, 1991, as a cadet assigned to Governor's Mansion Security in Olympia. He was commissioned December 20, 1991, with the 73rd Trooper Basic Training Class and assigned to Coulee City, working out of the Ephrata detachment. He transferred in 1996 to Kennewick.

His survivors include his wife, Billie; daughter, Megan; son, James; along with his parents John and Jan Saunders, and his sister Jennifer.



Trooper H. Douglas Cossman died on October 9, 1929, at the age of 28. He died from injuries he received in a collision with an automobile and his motorcycle at 46th & Park Avenue in Tacoma. At the time of his death, Trooper Cossman had served only 2 months with the Washington State Patrol as a trooper.



Trooper Irving Thorsvig was on his motorcycle August 29, 1926, going westbound on the old Bothell-Seattle highway when he slipped on the brick surface. A handle bar struck him in the chest. At first, it was believed to be a minor chest injury and later a bruised lung, but it developed into a serious lung problem. His mother took him to Los Angeles, but he died October 26, 1926, before reaching a sanitarium. Trooper Thorsvig had served 9 months with the Washington State Patrol.
