Introduced by Public Services Director Sullivan who gave an overview of Accessory Dwelling Units (ADU), the System Development Charges (SDC) and impact fees. He introduced a proposed amendment to the ordinance.

- Stormwater rates.
- SDC being paid when property is sold for single ADUs.
- Homeowner Association regulating ADUs.
- Maintaining character of neighborhoods.
- Thanked staff for all their hard work.
