Chairman Hollyfield read petition to the meeting, copy of same as amended per instructions of County Auditor in his letter of September 5, 1972 attached hereto and by this reference made a part of these minutes. Commissioner Booher moved to adopt resolution for merger: Ron Mickle seconded; motion adopted following polled vote as follows:

RESOLVED that Grant County Fire Protection District No. 10 does accept the merger of all assets and liabilities of Grant County Fire Protection District No. 9 as described in the petition hereto attached and that the combined territories shall be known as Grant County Fire District No. 10 and shall be operated as a single entity.

RESOLVED that the Board of Commissioners of Grant County Fire District No. 10 are unanimously agreed that the area described herein become a part of the territorial boundaries of said Fire District as soon as legally possible and,

RESOLVED that the Secretary of the Board of Commissioners Grant County Fire District No. 10 be directed to send a copy of this Resolution to the Board of County, Commissioners, Grant County, Washington and to Mr. J. F. Peddycord, Grant County, Auditor and ex officio Clerk of the Board of County Commissioners.
