A RESOLUTION BY THE CITY OF BONNEY LAKE, PIERCE COUNTY, WASHINGTON, AUTHORIZING JOANNA J. DANIELS, JUDGE OF THE BONNEY LAKE MUNICIPAL COURT, TO ENTER A MEMORANDUM OF UNDERSTANDING-B WITH RAINIER RECOVERY SERVICES, LLC. TO PROVIDE ON-SITE AND IN-CUSTODY EVALUATIONS.

WHEREAS The Bonney Lake Municipal Court motions for permission to enter into Memorandum of Understanding-B with Rainier Recovery Services, LLC, whereby Rainier Recovery Services, LLC shall provide substance use disorder evaluations to defendants who are in or out of custody. These evaluations will be available to defendants who are seeking an evaluation and to those who are court ordered to obtain such an evaluation. These evaluations shall be provided at no cost to the Court or to the City of Bonney Lake.



Short Background Summary (Use A Memo To Write A Full History): On June 9, 2024, The Bonney Lake Municipal Court Terminated Its Then Existing MOU With Rainier Recovery Services, LLC Upon Discovering That Unqualified Staff Were Conducting Evaluations Without Appropriate Supervision And Were Signing Off On Evaluations And Treatment Reports. Rainier Recovery Services, LLC Has Rectified This Situation And Is Currently Fully Staffed With Washington State Certified Substance Use Disorder Professionals, Substance Use Disorder Professional Trainees And Licensed Mental Health Professionals. This MOU Will Allow Rainier Recovery Services, LLC To Provide, At No Cost To The Municipal Court Or To The City Of Bonney Lake, On-Site And In-Custody Evaluations Of Defendants By Certified Evaluators As Well As Offer To And Provide Recommended Treatment For Bonney Lake Municipal Court Defendants. Schedule Mental Health Evaluations And/Or Other Services Which Benefit The Defendant.
