#### **ORDINANCE NO. 1728**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BONNEY LAKE, PIERCE COUNTY, WASHINGTON, AMENDING SECTION 8.04.190 OF THE BONNEY LAKE MUNICIPAL CODE TO AMEND THE ENFORCEMENT PROVISIONS FOR VIOLATIONS OF CHAPTER 8.04.190 OF THE BONNEY LAKE MUNICIPAL CODE; PROVIDING FOR SEVERABILITY AND CORRECTIONS; AND ESTABLISHING AN EFFECTIVE DATE.

**WHEREAS,** the only enforcement provisions for violations of Chapter 8.04 BLMC is the issuance of Class 1 Civil Infraction; and

**WHEREAS**, the proposed amendment would remove the Class 1 Civil Infraction and instead address violations using the City's code enforcement procedures outlined in Chapter 14.130 BLMC; and

**WHEREAS**, the City's code enforcement procedures prioritize achieving voluntary compliance before issuing fines;

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BONNEY LAKE, WASHINGTON, ORDAINS AS FOLLOWS:

**Section 1.** Section 8.04.190 of the Bonney Lake Municipal Code is hereby amended to read as follows:

#### 8.04.190 Violation – Penalties – Enforcement.

Any violation of this chapter, including but not limited to a failure to comply with the compulsory service requirement, shall be a Class 1 civil infraction under Chapter 7.80 RCW. The city code enforcement officer shall have the authority to issue civil infraction notices shall be subject to the enforcement provisions of Chapter 14.130 BLMC subject to the following:

- A. The amount of the civil penalties established in 14.130.030 and 14.130.100 are modified as provided below:
  - 1. The first violations within a twelve (12) month period shall be \$100
  - 2. The second violation within a twelve (12) month period shall be \$200

- 3. The third and each subsequent violation within a twelve (12) month period shall \$250.
- B. BMLC 14.130.030.D shall not apply to violations Chapter 8.04.190.

<u>Section 2.</u> <u>Severability.</u> If any section, sentence, clause, or phrase of this Ordinance should be held to be unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.

**Section 3. Publication.** This Ordinance shall be published by an approved summary consisting of the title.

<u>Section 3.</u> Corrections. Upon the approval of the city attorney, the city clerk, and/or the code publisher is authorized to make any necessary technical corrections to this ordinance, including but not limited to the correction of scrivener's/clerical errors, references, ordinance numbering, section/subsection numbers, and any reference thereto.

**Section 4. Effective Date.** This Ordinance shall be effective five days after publication as provided by law.
