


PLAT OF

Description

This Addition to Seattle, embraces the West $\frac{1}{4}$ of the North-West $\frac{1}{4}$ of Section 33, Twp 25 N. Range 4 East W.M.

The North-West corner of said section is 33 feet West and 23 $\frac{1}{2}$ feet North of the South-West corner of Block 8. Stone monuments are placed at the intersections of the center lines of Bancroft, Madison and Filbert Streets with the center lines of Toy, Chestnut and Hyde Streets, and said monuments govern the location of all lots, blocks, and streets in this plat.

Lots are 60 x 120 feet, except where otherwise shown on plat.

Streets are 66 ft. wide or as indicated on plat. Alleys are 16 feet wide.

Dedication

Know all men by these presents, that we, William Renton and Sarah M. Renton, husband and wife, Owners in fee simple of the above described "Renton's Addition to the City of Seattle", do hereby declare this plat, and dedicate to the use of the public forever all the Streets and alleys platted thereon. 
