Deputy Mayor Swatman:

<u>Communities For Families (CFF):</u> Deputy Mayor Swatman asked if Councilmember Fullerton is regularly attending the CFF meetings. Encouraged other Councilmembers to attend.

Blind Carbon Copy (BCC): Deputy Mayor Swatman asked a procedural question on when you can use BCC for Council.

<u>Pierce County Reginal Council (PCRC) Representation:</u> Councilmember Fullerton asked Councilmember Roach if he is still available to attend the PCRC meeting as the City's representative.

Councilmember Roach responded he was no longer able to represent the City at the PCRC meetings.

Councilmember Fullerton asked what the process is to have the City's representative changed.

City Attorney Jennifer Robertson stated the appointment can go on the consent agenda as a motion for the June 11, 2024, Council meeting.
