

RESOLUTION NO. 2869

A RESOLUTION OF THE CITY OF BONNEY LAKE, PIERCE COUNTY, WASHINGTON, AUTHORIZING EMERGENCY FUNDING TO THE BONNEY LAKE FOOD BANK.

WHEREAS, the Bonney Lake Food Bank (“Food Bank,” AKA Bonney Lake Community Resources) is a 501(c)3 charitable organization providing food and resources to individuals and families within the City of Bonney Lake; and

WHEREAS, the COVID-19 pandemic has had detrimental effects on the economy, which has increased the need for the Food Bank and related resources; and

WHEREAS, due to the pandemic, the Food Bank has incurred significant extra costs in 2020 for food, fuel, and expanded delivery services; and

WHEREAS, the Food Bank has requested financial and other forms of assistance from the City; and

WHEREAS, the Washington Constitution allows the City to provide financial assistance to organizations that care for the “poor or infirm;” and

WHEREAS, the Washington Constitution further allows the City to provide financial assistance to organizations that care for the health, safety, and general welfare of the public; and

WHEREAS, the City has received emergency funding under the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act, which reimburses eligible expenses incurred due to COVID-19.

NOW, THEREFORE, THE BONNEY LAKE CITY COUNCIL RESOLVES AS FOLLOWS:

A one-time donation of \$12,000 to the Bonney Lake Food Bank, for the purpose of assisting with the Food Bank’s increased costs due to the COVID-19 pandemic, is authorized. City staff are directed to apply for reimbursement of this expense from CARES Act funding.
