A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BONNEY LAKE, PIERCE COUNTY, WASHINGTON, AUTHORIZING JOANNA J. DANIELS, JUDGE FOR THE BONNEY LAKE MUNICIPAL COURT AND COMMUNITY COURT, TO SIGN A MEMORANDUM OF UNDERSTANDING-A, WITH RAINIER RECOVERY CENTERS, LLC WHEREIN RAINIER RECOVERY SERVICES, LLC SHALL PROVIDE ON-SITE AND IN-CUSTODY EVALUATIONS, AT NO COST, TO INDIVIDUALS OPTING INTO COMMUNITY COURT AND AUTHORIZING THE PAYMENT OF \$150 PER WEEK TO RAINIER RECOVERY SERVICES, LLC FOR SERVICES RENDERED BY A CERTIFIED PEER NAVIGATOR, SAID PAYMENT TO BE MADE FROM COMMUNITY COURT AOC GRANT (CONTRACT 1AA25060). THE TERM OF THIS MOU-FROM SEPTEMBER 25, 2024, TO JUNE 30, 2025.


WHEREAS The Bonney Lake Municipal Court Community Court continues to operate on a grant funded through the Administrative Office of the Courts Therapeutic Court Program under Contract #1AA25060 and the City of Bonney Lake does not provide any funding for the Community Court; and

WHEREAS The Bonney Lake Municipal Court Motions the City for permission to sign Memorandum of Understanding-A with Rainier Recovery Services, LLC to provide the services outlined in said Memorandum of Understanding-A and to authorize the Community Court to pay \$150.00 per week, from grant funds, for the services of a certified Peer Navigator whose duties are outlined in the Memorandum of Understanding-A. The Memorandum of Understanding-A shall become effective upon signing by Judge Daniels and the authorized representative of Rainier Recovery Services, LLC.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF BONNEY LAKE, WASHINGTON DOES HEREBY RESOLVE AS FOLLOWS:

Joanna J. Daniels, Judge of the Bonney Lake Municipal Court, is authorized to sign the Memorandum of Understanding-A with Rainier Recovery Services, LLC.

The Term Of This MOU-A September 25, 2024, To June 30, 2025.

Administrative Recommendation: Approve.

Short Background Summary (Use A Memo To Write A Full History): On June 9, 2024, The Bonney Lake Municipal Court Community Court Terminated Its MOU With Rainier Recovery Services, LLC When It Was Discovered That Unqualified Staff Were Conducting Evaluations And Signing Off On Treatment Reports Without Proper Supervision. Rainier Recovery Services, LLC Has Rectified These Issues And Is Now Fully Staffed With Washington State Certified Substance Use Disorder Professionals, Substance Use Disorder Professional Trainees And Licensed Mental Health Professionals. Rainier Recovery Services, LLC Will Provide, At No Cost To The Community Court, On-Site And In-Custody Evaluations Of Participants For Community Court. Rainier Recovery Will Also Provide A Certified Peer Navigator On Site At The Courthouse Each Friday From 2 Pm To 4:30 Pm To Meet With Community Court Participants And Provide Peer Support Services And Mandatory Meetings. Community Court Will Pay \$150 Per Week To Rainier Recovery Services, LLC For This Service From The AOC Continued Grant (Contract A25060). The City Of Bonney Lake Will Incur No Fiscal Responsibility For These Services.
