DESCRIPTION

This plat of "RIVIERA BEACH DIV. No. 4," AN ADDITION TO KING Co. WASHINGTON covers and includes all that portion of Government Lot 2, Sec. 27-Tp. 26 N. Range 4 E.W.M. lying east of the Northern Pacific Railway Right of Way and between parallel lines extended east and west through points in the meander line, distant respectively 250 feet and 500 feet, measured along the meander line, northerly of the extended south line of the plat of Lake City Addition to the City of Seattle; also all shore lands of the second class lying in front of and adjoining the foregoing described portion of government lot 2.

All dimensions are as shown upon the face of the plat in feet.

We hereby certify that the plat of "RIVIERA BEACH DIV. 4, AN ADDITION TO KING Co. WASHINGTON," is based upon an actual survey and subdivision of Section 27, Tp. 26 N.
