

Approve a resolution to adopt the East Pierce Interlocal coalition for Emergency Management (EPIC-EM) Comprehensive Emergency Management Plan (CEMP) 2024-2029 Edition.

Background:

The City of Bonney Lake's Emergency Management Division represents the City's commitment to plan for, respond to, and recover from natural, human-caused, and technological disasters.

The City of Bonney Lake is a member of EPIC-EM, and has been since 2022, with the City of Puyallup as the lead agency, and additional members including the Cities of Sumner, Orting, and Buckley, and Towns of Carbonado and Wilkeson. The Coalition was launched in February 2021 and soon after began the planning process to complete a regional CEMP with jurisdiction specific annexes. The purpose of the CEMP is to provide the policy framework by which other emergency plans are guided. The CEMP outlines how City departments organize, direct, control, and coordinate their actions to continue essential functions during incidents. The CEMP also contains policies, guidelines, and tasks as they relate to individual City department functions.

Per RCW 38.52.070, the review of a jurisdiction's CEMP is due every five years. As required under this Title, the CEMP was submitted for review to the Washington State Military Department Emergency Management Division at the end of 2023. The review of the CEMP is complete, and the next iteration of the EPIC-EM CEMP will be submitted to the State for review in five years.
